We, the undersigned, hereby declare that we desire to form a Society under the Societies Act, and that:

1. The name of the Society is "THE BRITISH COLUMBIA SOCIETY OF PHYSIO-THERAPY AND MASSAGE PRACTITIONERS."

2. The objects of the Society are:

(a) To promote training, education, qualifications, discipline, and honour of all persons practising or engaged as masseurs, or masseuses or physio-therapists.

(b) To promote the matter of sanitary conditions of all places where the practice of physio-therapy and massaging is performed.

(c) To call all masseurs, masseuses, and physio-therapists to become members of this Society and become registered and have status under the "Naturopathic Physicians Act Amendment Act, 1937, of the Province of British Columbia, and any amending Act or Acts thereto.

(d) To obtain representation by appointment of a member or members of this Society to the Board of Examiners and (or) the Board of Supervision, being the Boards created under and by virtue of the "Naturopathic Physicians Act," being chapter 204 of the "Revised Statutes of British Columbia, 1936," or any other Board that may be created under and by virtue of the said Act.

(e) To make provision by means of subscription of members for relieving sick or disabled members or members in distress.

3. The operations of the Society are to be chiefly carried on in the City of Vancouver, and in the Municipalities immediately surrounding the said City of Vancouver, in the Province of British Columbia.
